# Employment and Workforce Executive Director Dan Ellzey's Statement March 2020 Employment Situation

We understand that the numbers presented today are not a true depiction of the economic impact and unemployment in the month of March. So we wanted to offer some explanation as to how this process is completed and what we anticipate as we release April's data on May 22, 2020. Our release of data is a strict schedule set by the U.S. Bureau of Labor and Statistics that all states are ordered to adhere to, so please understand the data always has and will continue to reflect the month in arrears.

The government conducts a monthly survey called the Current Population Survey (CPS) to measure the extent of unemployment in the country. Each month, highly trained and experienced Census Bureau employees contact 60,000 eligible sample households and ask about the labor force activities (jobholding and job seeking) or non-labor force status of the members of these households during the survey week – which is the week of the 12<sup>th</sup> of each month.

#### **RESPONSE:**

"This survey was completed during the week of March 12. That was prior to the closings of many businesses and prior to our state truly experiencing the affects as we took shelter to combat COVID 19. We expect the release on May 22, 2020 to be a more accurate depiction of the current unemployment situation in our state," says Department of Employment and Workforce executive director, Dan Ellzey. "We know there is a continued uncertainty and many people are having problems filing claims. It is our goal to work with every one of these individuals to ensure their claim is filed and that they get a proper adjudication of it. While we are working with these individuals, we have been processing more than a quarter of a million claims within the last month. Prior to that, we processed approximately 7,000 claims per month. We have also been configuring our system to implement the five new federal programs."

Here's a breakdown of some continued good news:

- We are happy to report that South Carolina was one of the first states to not only implement, but pay out money for the weekly \$600 CARES Act program.
- We've paid out a total of \$67.5 million in regular UI benefits since claim week ending March 21, 2020.
- We've paid out a total of \$105.1 million in \$6000 CARES Act benefits so far.
- We anticipate being able to accept applications for Pandemic Unemployment Assistance (PUA) by the claim week ending April 25. To date, no other state has implemented or paid out PUA funding for self-employed, 1099, gig workers and those who don't qualify for regular UI.
- PEUC program (13 week extension of UI benefits) will be the last program to be rolled out in the coming weeks and will extend UI benefits to those who have already exhausted their 20 weeks.
- ChatBot: We have launched a new feature on our website to help folks find information with ease. Just go to dew.sc.gov and click the chat icon towards the top right of the homepage, if you're on a computer. If on a mobile device, click the menu in the top left corner and select the ChatBot option.
- Week over week, we've added additional staff members to assist claimants on the phones.
   We expect our total Customer Service Representatives to reach 500, by next week. We are ramping up as fast as possible, while providing a safe environment and proper training to ensure claimants receive meaningful assistance when they get through.

"We are all in this together and I assure you the Department of Employment and Workforce will continue to serve the good people of this state for the duration of this pandemic event."

# South Carolina's Employment Situation March 2020

# I. Household Survey<sup>1</sup>

Employment: The seasonally adjusted monthly survey of households referencing the week of March 12<sup>th</sup> estimated the number of South Carolinians working moved higher, establishing a new record of 2,334,652.

- That is an increase of 1,428 people over February 2020.
- That is also a significant increase of 43,290 people over March 2019.

Unemployment: Unemployment estimates increased to 61,898 people.

- That is a significant increase of 3,267 people since February 2020 and a significant decrease of 17,983 over March 2019.
- The state's seasonally adjusted unemployment rate increased to 2.6 percent over the month from February's rate of 2.5 percent.
- Nationally, the unemployment rate moved higher from 3.5 percent in February to 4.4 percent in March, thus reflecting some of the early effects of the Coronavirus (COVID-19) on the household survey data. This change is the largest over-the-month since January of 1975, when it was also 0.9 percentage point.

Labor force: The state's estimated labor force (people working plus unemployed people looking for work) increased to 2,396,550.

- That is an increase of 4,695 people since February 2020.
- That is an increase of 25,307 individuals over March 2019.

# II. Current Employment Survey<sup>2</sup>

# Nonagricultural Employment by Industry (Seasonally Adjusted<sup>3</sup>)

The Current Employment Survey of businesses in South Carolina marked a decrease of 13,400 nonfarm payroll jobs over the month to a level of 2,203,700.

• Industries reporting increases in employment were Government (+900); Financial Activities (+600); and Manufacturing (+200).

• Decreases were noticed in the Leisure and Hospitality (-10,200); Trade, Transportation and Utilities (-2,200); Construction (-900); Other Services (-800); Education and Health Services (-700); Information (-100); and Professional and Business Services (-100) industries.

From March 2019 to March 2020, South Carolina's economy has added 28,900 seasonally adjusted nonfarm jobs.

- Industries with strong growth were Professional and Business Services (+8,700); Government (+7,800); Leisure and Hospitality (+3,500); Construction (+2,700); Trade, Transportation, and Utilities (+1,900); Education and Health Services (+1,900); Manufacturing (+1,300); Financial Activities (+700); Other Services (+200); and Information (+200).
- No industries reported decreases over the year.

# Nonagricultural Employment by Industry (Not Seasonally Adjusted<sup>2</sup>)

Not seasonally adjusted, nonfarm payroll employment increased by 100 from February 2020 to March 2020 for a total of 2,195,900.

- Industries showing growth during this period were: Government (+2,300); Education and Health Services (+1,100); Financial Activities (+300); and Information (+200).
- Industries reporting declines were Leisure and Hospitality (-1,800); Construction (-1,100); Trade, Transportation, and Utilities (-400); Other Services (-300); and Professional and Business Services (-200). Mining and Logging and Manufacturing remained flat.

Since March 2019, not seasonally adjusted nonfarm jobs were up 27,600 overall in South Carolina.

- Industries marking prominent annual gains were Professional and Business Services (+7,400); Government (+6,800); Leisure and Hospitality (+4,800); Education and Health Services (+2,800); Construction (+2,500); Trade, Transportation, and Utilities (+1,500); Manufacturing (+1,100); Financial Activities (+500); Information (+100); and Other Services (+100).
- No industries recorded an over the year loss. Mining and Logging remained flat.

**Footnote:** It is important to keep in mind that the March survey reference periods for both surveys predated many coronavirus-related business and school closures in the second half of the month.

<sup>1</sup>Household Survey (Current Population Survey): is a monthly survey of about 60,000 households conducted by the Census Bureau for the Bureau of Labor Statistics. This survey provides monthly statistics on employment, unemployment, and related subjects analyzed by the Bureau of Labor Statistics.

<sup>2</sup>Current Employment Statistics Survey: is a monthly survey of about 40,000 employers which yields estimates of nonagricultural wage and salary employment, hours, and earnings by industry.

<sup>3</sup>Seasonally Adjusted: Seasonal adjustment removes the effects of events that follow a more or less regular pattern each year (i.e. tourist-related hiring and school closings in the summer). These adjustments make it easier to observe the cyclical and other nonseasonal movements in data over time.

<sup>4</sup>Not Seasonally Adjusted: Effects of regular or seasonal patterns have <u>not</u> been removed from these data.
